Attached is a summary of the bids received on the eight surplus vehicles we had advertized for sale. We received 18 bids on five of the vehicles and had a bid opening on January 29, 2014. The two bids received on the 2003 Ford Explorer were subsequently withdrawn. Four vehicles were sold through the bid process and two other vehicles were sold after negotiating an agreeable price. Six vehicles were sold for a total of \$19,901.

We have two remaining surplus vehicles. The 2008 Ford Escape Hybrid AWD and the 1995 Ford F250 Utility Bed 4x4. We have reduced the prices slightly and are advertizing them for sell.
