## **RESOLUTION NO. 446**

A RESOLUTION OF THE CRESTLINE VILLAGE WATER DISTRICT ADOPTING AND AUTHORIZING REVISIONS TO THE LOCAL HAZARD MITIGATION PLAN WHICH IS PART OF THE SAN BERNARDINO COUNTY OPERATIONAL AREA'S MULTIJURISDICTIONAL HAZARD MITIGATION PLAN.

WHEREAS the Disaster Mitigation Act of 2000 (DMA 2000) (Public Law 106-390) amended the Robert t. Stafford Disaster Relief and Emergency Assistance Act (the Act;

WHEREAS to implement the DMA 2000 planning requirements, the Federal Emergency Management Agency (FEMA) published Interim Final Rules (IFRs) in the Federal;

WHEREAS these Interim Final Rules established the mitigation planning requirements for local governments and required that in order to remain eligible to receive federal funding for both pre-disaster and post-disaster mitigation project funding, a local government must have a FEMA approved and locally adopted Local Hazard Mitigation Plan written in accordance with the Act and updated every five years;

WHEREAS the Federal Emergency Management Agency has endorsed both Local and Multi-Jurisdictional Hazard Mitigation Plans as a partnership encouraging multi hazard approaches to disaster resistant communities;

WHEREAS the Crestline Village Water District has established both a local and multijurisdictional partnership with the County of San Bernardino to include their specific risks, hazards, current and future mitigation measures and goals and objectives.

BE IT THEREFORE RESOLVED that the Board of Directors of the Crestline Village Water District hereby adopts the 2018 Local Hazard Mitigation Plan (which revises the 2010 Local Hazard Mitigation Plan adopted June 21, 2011) and approves its inclusion in the County of San Bernardino Multi-Jurisdictional Hazard Mitigation Plan.
