Subject: Rogers, Anderson, Malody, & Scott, LLP

Rogers, Anderson, Malody and Scott (RAMS) currently provide the District with an "Engagement Letter" each year for audit services. This letter provides the scope of the audit and what is provided by the District and what is provided by RAMS. RAMS internal budget for the District audit is \$24,000 annually. They attempt annually to stay below the \$24,000 mark.

Scott Manno of Rogers, Anderson, Malody & Scott (RAMS) provided the District with our audit costs for fiscal years ending 2014 through 2018. The District verified these amounts and added prior years ending 2008-2013. In addition, Mr. Manno provided RAMS' actual costs for the prior three years; RAMS changed billing systems and only has three years of information available to them. The actual cost was considerably higher than the billed cost for the three years recorded.
