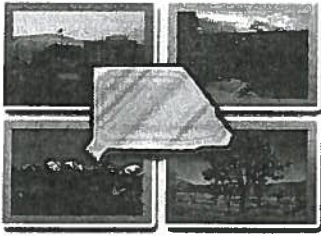

The staff of the Local Agency Formation Commission conducted a mailed ballot Special District Selection process, which closed at 5:00 p.m. on April 14, 2014 with all original ballots due no later than April 25, 2014. I am pleased to announce that we have had a successful election with the participation of 34 Districts. LAFCO staff received 32 valid ballots for the Regular Special District member and 30 valid ballots for the Alternate Special District member, exceeding the minimum 26 ballots required. A copy of the election results is attached.

The following is the selection made:

**REGULAR MEMBER:**

James Curatalo	26 votes
Al Morrissette	6 votes

**ALTERNATE MEMBER:**

Robert Smith	12 votes
Steven Farrell	18 votes

Mr. Curatalo and Mr. Farrell will be sworn into office on May 21, 2014. The term of office will expire on the first Monday in May 2018.
