INACTIVATION OF CYPRESS VERTICAL WELL – CRESTLINE VILLAGE CWD – DIVISION 10 – (SYSTEM NO. 3610015)

This letter documents the inactivation of Cypress Vertical Well (PS Code: 3610015_056_056). The State Water Resources Control Board, Division of Drinking Water (Division) received an e-mail dated February 21, 2024 (Enclosure 1) from Crestline Village CWD – Division 10 public water system (District) requesting that Cypress Vertical Well to be inactivated. The email also attaches photos demonstrating that Cypress Vertical Well has been physically separated from the system (Enclosure 2).

The Division hereby changes the status of the well from "Active" to "Inactive." The well is no longer required to be monitored for water quality and cannot be used as a potable source without first obtaining a permit amendment from the Division. However, if the District continues to monitor the well under inactive status, the Division encourages the District's laboratory to continue to submit the results electronically to California Laboratory Intake Portal (CLIP). If the well will no longer be used, the District should properly destroy the well per Department of Water Resources (DWR) Bulletins 74-80 and 74-90. Please forward a copy to the San Bernardino County well destruction permit and DWR destruction log if/when completed.
